## Borough Council Minutes – November 22, 2016

**Call to Order** – Mr. Farley called the meeting to order at 6:00pm. Mr. Flick offered the meeting prayer and led the Pledge of Allegiance.

**Roll Call** – The following members of the Borough Council were present; James Daly, Robert Flick, Eugene Osmun, Timothy Shaw, Irene Slocum, Eugene Cerutti, and Henry Farley. **Also present;** Mayor Denny Thomas, Elizabeth Fice, Finance Coordinator; Daniel Reynolds, Police Chief; Gilbert Crossett, Fire Chief; Tracy Stroup, 1<sup>st</sup> Assistant Fire Chief; Blane Lathrop, DPW Foreman; Christopher Kaiden, Code Enforcement Director; and David Jarrett, Borough Manager.

**Approval of the Minutes** – The minutes of the Borough Council meeting on October 26, 2016 and special meeting on November 3, 2016 were approved as presented.

**Citizens to be Heard** – The following citizens addressed the Borough Council regarding the Valor Street sewer project;

- Sherry Williams 116 Valor Street Ms. Williams stated the condition of the roadway and the restoration of the tree line and front yard is unacceptable.
   Ms. Williams stated that she understands the project is not completed but better restoration of the temporary work is needed.
- Jane Bustin 114 Valor Street Ms. Bustin stated that the she is concerned with the restoration of the tree line area in front of her home.

Mr. Lathrop explained that the paving restoration had to be completed before the area blacktop plants closed for the season and that modified material was used along the edge of the road because it is better than top soil at this point in the project. Mr. Lathrop also stated that Aqua PA will be completing improvements to the waterline on the street and that it is not practical to do final restoration before that work is completed. Mr. Lathrop stated that he will contact the project inspector and construction foreman and visit the site next week.
