This letter is in reference to the detour route for the subject project. The scope of work for this project is to replace the existing one-lane bridge carrying T-105 (N. Thomas Avenue) over Cayuta Creek with a new two-lane bridge. The project is located in Athens Township and Sayre Borough. The project is located approximately 0.25 miles southwest of the intersection of Cayuta Street and T-105 (N Thomas Avenue).

It was determined to utilize a detour for this project to minimize time of construction as well as to reduce environmental and right-of-way impacts to the area adjacent to the project. Two detours will be implemented: a detour route for vehicles (i.e. cars, pick-up trucks, single unit / delivery trucks, etc.) and a truck detour route for larger vehicles (i.e. tractor trailers).

The detour will be 2.2 miles in length and will utilize the following routes, as referenced on the enclosed detour plan:

- Beginning at the intersection of T-105 (N Thomas Avenue) and W Packer Avenue
- W Packer Avenue to Desmond Street
- Desmond Street to N Lehigh Avenue
- N Lehigh Avenue to Spring Street
- Spring Street to Cayuta Street
- Concluding at the intersection of Cayuta Street and T-105 (N Thomas Avenue)

The proposed truck detour will be used for large vehicles. This detour will be 11.9 miles in length and will utilize the following routes, as referenced on the enclosed detour plan:

- Beginning at the intersection of T-105 (N Thomas Avenue) and E Lockhart Street
- E Lockhart Street to Riverside Drive
- Riverside Drive to SR 1056 (Front Street)

- S Main Street to SR 0199 (Tioga Point Lane)
- SR 0199 (Tioga Point Lane) to SR 0220
- SR 0220 to SR 0017
- SR 0017 to Spring Street
- Spring Street to Cayuta Street
- Concluding at the intersection of Cayuta Street and T-105 (N Thomas Avenue)

The project is currently in the early stages of construction. The detours are anticipated to be implemented on November 13, 2023. The detours will remain in place throughout construction and are anticipated to be removed in July 2024, provided no unforeseen circumstances occur beyond the Township's control and/or no delays are encountered due to inclement weather.

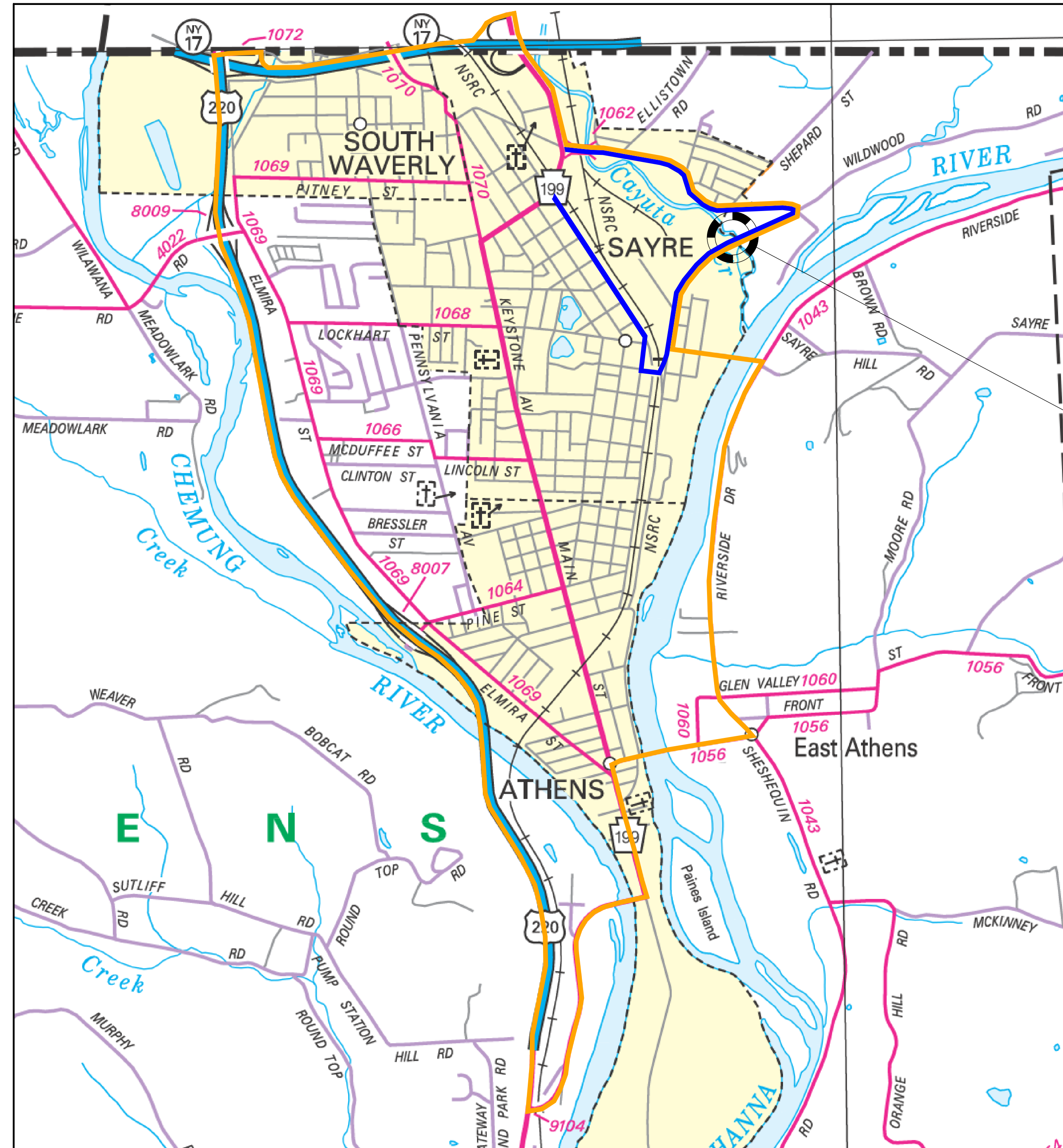
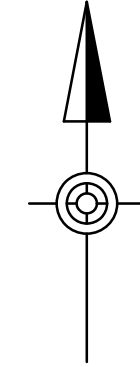
